Whereas

MAIT is an Educational Institute Engaged in imparting Education through its Affiliation with

Guru Gobind Singh Indraprastha University (GGSIPU), Delhi, is Desirous of availing Medical facilities

From the aforesaid medical organisation that is SAIH, ^{Rohini} Punjabi Bagh, Delhi for its faculty members, staff, and students.

Whereas

Shree Aggarsain International Hospital (SAIH), is a Multi- Speciality Hospital and is managed by Shree Aggarsain North Ex Welfare Society(Regd.), Agrees to provide various medical Facilities to the Employees of MAIT, their Families and Students.

This MOU is Agreed upon, by and between the parties as follows:

That in case of emergency MAIT'S Employees/ Family members/ Students shall be provided with the immediate treatment on the basis of priority.

That MAIT'S Employees / Family members / Students shall also be provided priority for Casual Routine check-up as per Hospital Norms.

The MAIT employee's and family members or students shall prevail the services on cash basis to hospital tariff with the following discounts:

1. 20 % discount on IPD admissions (excluding implants, medicines, consumables) & lab investigations, (excluding outsourced tests).
2. 10 % discount on Radiological investigations, Preventive health packages, Physiotherapy & Private OPD Consultations, OPD procedures. (excluding consumables & implants)

This agreement shall be for the period of One-year from 1st October 2018 (effective date) till 1st October 2019.

Any clauses in the MOU or an addendum shall come into effect after the written approval from both the parties.
