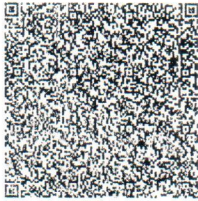

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on this 01st day of July, 2024 at Delhi between Maharaja Aggarsain Institute of Technology through its Director Prof. Neelam Sharma at Sector-22, Rohini, New Delhi-110086 (hereinafter referred as MAIT) which expression shall, unless excluded by or repugnant to the context or meaning thereof be deemed to mean and include its successors in the hospital and assigns of the ONE PART.

And


Shree Aggarsain International Hospital through its Medical Superintendent, having its registered office at PSP, Sector-22, Rohini, New Delhi-110086 (hereinafter referred as SAIH) which expression shall, unless excluded by or repugnant to the context or meaning thereof be deemed to mean and include its heirs, successors, executors, administrators and assignees of the OTHER PART.

Whereas MAIT is an Educational institute engaged imparting education through its affiliation with Guru Gobind Indraprastha University (GGSIPU), Delhi is desirous of availing Medical Facilities from the aforesaid medical organization that is SAIH, Rohini, Delhi for its faculty members, staff and students.

Whereas Shree Aggarsain International Hospital (SAIH), is a Multi-Specialty Hospital and is managed by Shree Aggarsain North Ex Welfare Society (Regd.) agrees to provide various medical facilities to the employees of MAIT, their family members and students.


The MOU is agreed upon, by and between the parties as follows:

1. That in case of Emergency MAIT employees, their family members and students shall be provided with the immediate treatment on the basis of priority subject to norms and procedure established and followed by the SAIH.
2. That MAIT MAIT employees, their family members and students shall also be provided priority for casual routine check-up as per hospital norms subject to norms and procedure established and followed by the SAIH.
3. The MAIT employees, their family members and students shall avail the services cash basis on to prevailing / current hospital tariff with following discount:
 - 20% discount on IPD admission excluding Implants, Medicines and Consumables & Lab Investigations, (Excluding outsourced Investigations)
 - 10% discount on Radiology investigations, preventive health packages, physiotherapy and private OPD consultancy, OPD procedures (Excluding Consumables & Implants).

4. That providing discounted services and facilities as mentioned hereinabove in this MOU shall be sole discretion of the SAIH and if any violation occurs on the part of MAIT, SAIH may repudiate or terminate the applicable discount at any time subject to advance 7 days prior written notice to MAIT.
5. That discounted services and facilities applicable only for the working and current students, employees and family members of the current employees only.
6. That discounted services and facilities shall be provided only to those who will produce the valid photo identity card on demand of the SAIH issued by the MAIT or any equivalent authority letter issued by the MAIT in case valid identity card is not available.
7. This agreement shall be for the period of two years from 01.07.2024 to 30.06.2026. Any clause in MOU or an addendum shall come into effect after the written approval from both the parties.
8. Present MOU between the parties is final and absolute and prevail and supersedes over any other previous MOU or any other oral agreement.


