

2. The total fee (through demand draft in favour of Registrar, GGSIPU) is to be submitted in the Accounts Division of EXAMINATION DIVISION through Indian Bank and after due receipt by Accounts Division, the Examination Registration Chart to be submitted with Conduct Division in duplicate.
3. Total fee payable by each student for re-appear papers has been indicated for each semester in the enclosed Registration Chart. The STUDENT MUST PAY THE ENTIRE FEE IN FULL AS MENTIONED in the Registration Chart.
4. If the name of a student is missing in the Registration Chart (i.e. for addition of student in the Registration Chart), the student's Examination OMR Form should be submitted along with the Registration Chart and the proof of admission; and a separate list of these cases and the requisite reappear fees is to be submitted (if applicable).
5. If the name of a student is to be deleted from the Registration Chart, a separate list of these cases along with the University admission cancellation order etc. may be submitted.
6. In instances where student (s) enrollment number is reflected as NA-XXXXX, the list of enrollment numbers (in each case) issued by the University (together with a copy of the University order) should be submitted within two weeks of submission of the Registration Chart to the conduct division of the Examinations division.
7. Data regarding migration cases pertaining to the above mentioned programme is to be submitted as a separate list (together with a copy of the University order pertinent in these cases). For migration/upgradation cases from within the University, the old enrollment number should be mentioned in the list.
8. In case of missing/incorrect photograph/signature of the student, the student's Examination OMR form and a separate list of such students should be submitted.
9. If any paper(s) is missing and hence required to be added in the Registration Chart, the same may be submitted separately with the details of the fee (in applicable).
10. Student's signature column should be signed by the student; in exceptional situations, the Dean of the School/Director of Principal of the Institution may certify. A separate list of these is to be submitted along with reasons thereof.
11. The signature of the authorized signatory (with the institution seal) from the school/institution for the course is mandatory on every sheet. **Please do not put a stamp of the signature.**
12. Applicable scheme (s) of studies is enclosed for reference. Every scheme is identified by an unique Scheme ID and the applicable Scheme ID for a student is reflected in the Student's Details portion of the Registration Chart.
13. Any variance in the record of any student (including student status, name, father's name etc.) may be communicated.
